## AGOVA CAN HELP ... SIGN UP FOR NOTIFICATIONS

### Community Notification

A victim of a sexual offense has the right to request notification of the release of an inmate, the date of release, and the location of the inmate's residence by the AGOVA.

### Pardon and Parole Protest

The Alabama Board of Pardons and Paroles notifies the AGOVA and victims when an inmate convicted of a violent crime is scheduled for a pardon or parole hearing. The AGOVA submits written protests against the early release of all violent offenders. In addition, at the request of the victim, the AGOVA Officers attend the hearing to assist you and provide support.

### Appellate Notification

The AGOVA Officers provide appellate notification assistance to victims of violent crimes who have registered with the AGOVA. During the appeals process, the AGOVA notifies violent crime victims of appellate court hearings, and accompanies victims to hearings to provide support and assistance during court proceedings.

## WHERE DO I START?

Being the victim of a crime is traumatic. You may feel isolated and confused without knowing where to turn for advice and support. You should know there are many state and community resources available (see Important Resources on the back of this brochure) to help you and explain your rights as a victim under Alabama law. Victims Officers at the **Attorney General's Office of Victim Assistance (AGOVA)** are here to help you understand and exercise your rights. Below you will find some basic information about your rights as a crime victim. (ALA CODE §15-23-60 et seq.)

## WHAT ARE MY RIGHTS?

As a victim of crime in Alabama, you have a Constitutional right to be treated with fairness, respect, dignity, and to be informed and present throughout the criminal justice process. All state, county, and municipal justice agencies and courts in Alabama are required to perform certain duties to ensure your rights are upheld. Some of these rights are:

- A list of local emergency and crisis services.
- The name and telephone number of the officer and law enforcement agency handling your report.
- The procedural steps in a criminal prosecution.
- The availability of victim's compensation benefits.
- A listing of your rights as a victim, including a form to help you assert your rights.
- The existence and eligibility requirements of restitution and compensation.
- A recommended procedure in case you are subjected to threats or intimidation as a victim.
- Notification of all criminal proceedings and charges filed against the defendant and the right to be present at all proceedings.
- An explanation of the pre-sentence report and the right to make a written or oral statement to the probation officer.
- Notification of date, time, and location of any sentencing hearing and to present any information at a sentencing proceeding.
- Information regarding the return of any property taken during the course of the investigation.
- Be provided the date of conviction, acquittal, or dismissal of charges against the defendant and the sentence imposed.
- Refuse an interview or other communication with the defendant, their attorney, or anyone acting on their behalf.
- The status and result of any post-conviction appeal.
- Be supplied a waiting area separate from the defendant, his relatives, and defense witnesses (if available and practical).
- Submit a statement to be entered into the offender's records.
- Notification of release from prison, on bond, escape, re-arrest, or death of the defendant.
